Bondholder/Non-Equity Membership Includes:

- ✓ Main member has full use of golf course, pool, fitness center, and dining facilities. Spouse and children 21 and under may use pool, fitness center with restrictions, and dining facilities. Bondholders have voting rights and can hold elected office.
- ✓ As a bondholder, initiation and bond are due upfront. As a non-equity, the initiation is due upfront and the bond is paid when one is available. Dues may be paid monthly over 11 months or upfront.
- ✓ \$125 per month Dining Room Food Minimum or you may choose semi-annual option of \$1,500 per year (\$750 February through June and \$750 July thru December).

After the initiation and bond is paid in full, members will be considered a full equity Bondholder. Once a bond becomes available for a Non-Equity member, the bond can be paid and member will be a Bondholder.

Social Membership Includes:

- ✓ Full use of pool, fitness center, and dining facilities for spouse and children 21 and under. Socials do not have voting rights and cannot hold elected office.
- ✓ Main member allowed to play golf twice a month with cart fee only. No play before 11a.m. Saturday, Sunday, Holidays. Range and practice areas allowed for use on the two days that the member is playing golf.
- ✓ Dues may be paid monthly over 11 months or upfront. Initiation and deposit fees must be paid upfront. Dues will not be pro-rated.
- ✓ \$125 per month Dining Room Food Minimum or you may choose semi-annual option of \$1,500 per year (\$750 February through June and \$750 July thru December).

Junior Membership Includes:

- ✓ Has use of the golf course. Club facilities and unrestricted use of the practice areas and the use of the pool. Juniors have no voting rights and cannot hold elected office.
- ✓ Dues may be paid monthly over 11 months or upfront. Initiation and Deposit fees must be paid upfront.
- ✓ \$125 per month Dining Room Food Minimum or you may choose semi-annual option of \$1,500 per year (\$750 February through June and \$750 July thru December).
